1. Suppose we have

$$\mathbf{u}_1 = \begin{bmatrix} 1 \\ 1 \\ 1 \end{bmatrix}, \mathbf{u}_2 = \begin{bmatrix} 2 \\ 1 \\ 0 \end{bmatrix}, \mathbf{u}_3 = \begin{bmatrix} 0 \\ 2 \\ -2 \end{bmatrix}.$$

(a) (5 points) Is $\{\mathbf{u}_1, \mathbf{u}_2, \mathbf{u}_3\}$ a basis for \mathbb{R}^3 ? Justify your answer.

(b) (7 points) Run the Gram-Schmidt procedure on $\{\mathbf{u}_1, \mathbf{u}_2, \mathbf{u}_3\}$.

(c) (4 points) Let $\{\mathbf{v}_1, \mathbf{v}_2, \mathbf{v}_3\}$ denote the basis found by Gram-Schmidt in part (b).

Let $\mathbf{x} = \begin{bmatrix} 1 \\ 3 \\ -1 \end{bmatrix}$. Find coefficients c_1, c_2 and c_3 so that $\mathbf{x} = c_1\mathbf{v}_1 + c_2\mathbf{v}_2 + c_3\mathbf{v}_3$.

(d) (4 points) Let $\mathbf{x} = \begin{bmatrix} 1 \\ 3 \\ -1 \end{bmatrix}$, and $S = \text{span}\{\mathbf{u}_1, \mathbf{u}_2\}$ where $\mathbf{u}_1, \mathbf{u}_2$ are as in part (a).

Find $\text{proj}_S \mathbf{x}$.

2. (a) (5 points) Let $A = \begin{bmatrix} 2 & 1 & 0 \\ 0 & 3 & 1 \\ 0 & 1 & 1 \end{bmatrix}$. Is A^3 invertible? Explain. If it is, find the determinant of the inverse of A^3 . In other words, find $\det((A^3)^{-1})$.

- (b) (5 points) Suppose $\{\mathbf{u}_1, \mathbf{u}_2, \mathbf{u}_3, \mathbf{u}_4\}$ is an orthonormal basis for \mathbb{R}^4 , and let $U = [\mathbf{u}_1 \mathbf{u}_2 \mathbf{u}_3 \mathbf{u}_4]$ be the corresponding 4×4 matrix. What is $U^T U$? Explain.

3. Given two sets A and B , we will use $A \cup B$ to denote their union - that is, $A \cup B$ is the set of all vectors that are in at least one of A, B . We will use $A \cap B$ to denote their intersection - that is, $A \cap B$ is the set of all vectors that are in both A and B .
- (a) (5 points) Suppose S_1 and S_2 are subspaces of \mathbb{R}^n and $S = S_1 \cup S_2$. For each of the three subspace conditions, decide whether that condition is always satisfied by S . If it is not, provide a counter-example.
- (b) (5 points) Suppose S_1 and S_2 are subspaces of \mathbb{R}^n and $S = S_1 \cap S_2$. For each of the three subspace conditions, decide whether that condition is always satisfied by S . If it is not, provide a counter-example.

4. Let $A = \begin{bmatrix} -1 & 2 \\ 2 & -1 \end{bmatrix}$.

- (a) (5 points) Compute the characteristic polynomial of A and find the eigenvalues λ_1 and λ_2 .

- (b) (5 points) For one of the eigenvalues in part (a) (it doesn't matter which you pick), find a basis for the corresponding eigenspace.

5. Decide whether the following statements are true or false, and circle the explanation that best explains why.
- (a) (3 points) 5 vectors in \mathbb{R}^4 cannot form an orthogonal set.
1. True. Orthogonal sets are always linearly independent, and 5 vectors cannot be linearly independent in \mathbb{R}^4 .
 2. True. This follows from the big theorem.
 3. False. Consider for example $\{\mathbf{e}_1, \mathbf{e}_2, \mathbf{e}_3, \mathbf{e}_4, \mathbf{0}\}$, where $\mathbf{e}_i \in \mathbb{R}^4$ is the vector with a one in the i th position, zeros elsewhere.
 4. False. In 4 dimensions we can space out 5 unit vectors so they are all orthogonal.
- (b) (3 points) For any square matrix A , $\det(5A) = 5 \det(A)$.
1. True. $\det(5A) = \det((5I)A) = \det(5I) \cdot \det(A) = 5 \det(A)$.
 2. True. The determinant is a linear map.
 3. False. Consider for example A being the zero matrix.
 4. False. Consider for example $A = I$.
- (c) (3 points) If A and B are invertible $n \times n$ matrices, then $AB = BA$.
1. True. We know $ABA = ABA$, and then we can multiply both sides of the equation by A^{-1} to get $AB = BA$.
 2. True. Invertible matrices are always diagonalizable, and we can compute that $AB = BA$ for diagonal matrices.
 3. False. Consider the matrices $A = \begin{bmatrix} 0 & 1 \\ 1 & 0 \end{bmatrix}$ and $B = \begin{bmatrix} 2 & 0 \\ 0 & 1 \end{bmatrix}$.
 4. False. Consider the matrices $A = \begin{bmatrix} 0 & 1 \\ 1 & 0 \end{bmatrix}$ and $B = \begin{bmatrix} 1 & 2 & 3 \\ 4 & 5 & 6 \end{bmatrix}$. Notice that the multiplication BA is not even defined.
- (d) (3 points) If A is an $n \times m$ matrix with linearly independent columns, then $\text{row}(A) = \mathbb{R}^m$.
1. True. The number of rows is at least m , and so they must span \mathbb{R}^m .
 2. True. The dimension of $\text{col}(A)$ is m , and so the dimension of $\text{row}(A)$ is also m .
 3. False. We might have $n \neq m$, and so the big theorem does not apply.
 4. False. Consider the matrix $A = \begin{bmatrix} 1 & 0 & 1 \\ 0 & 1 & 2 \end{bmatrix}$. We have $m = 3$ but there are only two row vectors, so their span can't be all of \mathbb{R}^3 .
- (e) (3 points) If A is an $n \times m$ matrix with orthogonal columns, then the rows of A are also orthogonal.
1. True. The dimensions of the row space and column space are the same, so if the columns are orthogonal then so are the rows.
 2. True. Notice that the columns of A are precisely the rows of A^T .
 3. False. Consider for example the matrix $\begin{bmatrix} 1 & -1 \\ 1 & 1 \end{bmatrix}$.
 4. False. Consider for example the matrix $\begin{bmatrix} 1 & -1 \\ 1 & 1 \\ 0 & 1 \end{bmatrix}$.

6. Read each of the following statements carefully, and decide whether it is true or false. You are not required to justify your answers, but I recommend justifying them to yourself.

(a) (2 points) If $\mathbf{y} \in \text{col}(A)$, then any least-squares solution to $A\mathbf{x} = \mathbf{y}$ is in fact a solution to $A\mathbf{x} = \mathbf{y}$.

(b) (2 points) Suppose a linear system has 5 variables and 3 equations, and $\mathbf{x} = \begin{bmatrix} 1 \\ 2 \\ 3 \\ 4 \\ 5 \end{bmatrix}$ is a solution to the system. Then the system has infinitely-many solutions.

(c) (2 points) Suppose a linear system has 3 variables and 5 equations, and $\mathbf{x} = \begin{bmatrix} 0 \\ 0 \\ 0 \end{bmatrix}$ is a solution to the system. Then the system has only the trivial solution.

(d) (2 points) If a diagonal matrix has all nonzero entries along the diagonal, then it is invertible.

(e) (2 points) If A is an $n \times n$ matrix, then $\text{row}(A) = \text{col}(A)$.

(f) (2 points) If T_1 and T_2 are linear transformations from \mathbb{R}^m to \mathbb{R}^n and we define $T(x) = T_1(x) + T_2(x)$, then T is also a linear transformation.

(g) (2 points) Suppose \mathbf{x}_1 and \mathbf{x}_2 are vectors in \mathbb{R}^m , and A is an $n \times m$ matrix. If \mathbf{x}_1 and \mathbf{x}_2 are both solutions to the equation $A\mathbf{x} = \mathbf{0}$, then so is the vector $\mathbf{x}_1 + \mathbf{x}_2$.

(h) (2 points) The set $\left\{ \begin{bmatrix} 2 \\ 3 \\ 0 \\ 7 \end{bmatrix}, \begin{bmatrix} 4 \\ 2 \\ 0 \\ 2 \end{bmatrix}, \begin{bmatrix} 4 \\ 8 \\ 0 \\ 3 \end{bmatrix}, \begin{bmatrix} 1 \\ 15 \\ 0 \\ 0 \end{bmatrix} \right\}$ is linearly independent.

(i) (2 points) The set $\left\{ \begin{bmatrix} 1 \\ 2 \\ 3 \end{bmatrix}, \begin{bmatrix} 4 \\ 5 \\ 6 \end{bmatrix}, \begin{bmatrix} 7 \\ 8 \\ 9 \end{bmatrix} \right\}$ is linearly independent.

(j) (2 points) If $T_1 : \mathbb{R}^m \rightarrow \mathbb{R}^k$ and $T_2 : \mathbb{R}^k \rightarrow \mathbb{R}^n$, define $T : \mathbb{R}^m \rightarrow \mathbb{R}^n$ by $T(\mathbf{x}) = T_2(T_1(\mathbf{x}))$. If T_1 and T_2 are onto linear transformations, then T is also an onto linear transformation.

7. Give an example of each of the following:

(a) (5 points) A 2×2 matrix so that $A^2 = 0$ but $A \neq 0$.

(b) (5 points) A 3×3 matrix A so that $A^3 = 0$ but $A^2 \neq 0$. (Hint: Think about how your matrix in (a) acts on the standard basis vectors)

(c) (5 points) A 2×3 matrix A and a 3×2 matrix B so that $AB = I_2$ but $BA \neq I_3$.
